NOTES TO FINANCIAL INFORMATION

Additional Fees

1. If you are undertaking the *M.Sc. International Management* programme you must make allowance for pre-programme costs as follows:

Intensive Management	BDS \$1,200
Intensive Language	BDS \$1,500

2. If you are undertaking the *M.Sc. International Trade Policy* programme you must make an additional allowance of BDS \$5,000 for the one-month overseas attachment that forms an integral part of their programme.
3. If you are undertaking the *Postgraduate Diploma / MSc Information Technology(Enterprise Systems, Mobile Applications, Web Development)*, you must make provision for an additional BDS \$5,000 to cover the cost of a specialized laptop and a mobile phone that are essential for these programmes.

Registration and Fees

- Fees are generated by on-line registration.
- You are expected to register on-line during the first week of every semester until your degree has been awarded.
- Registration is done on-line through Cave Hill On-Line (CHOL) and you are required to identify **every** programme element – *course, thesis, workshop, seminar, research paper, etc* being undertaken that semester.
- The requirement to register online and pay relevant fees every semester **continues** while you are doing your Thesis/ Research Paper/ Practicum/ Internship.
- You are permitted to make changes to course registration until the end of the third week of the semester.
- If your fees are being paid by your Government or other sponsor you should note that these invoices are submitted by the University at the end of the third week of each semester. It is therefore **essential** that if you have any difficulty registering that you email your faculty clerk in Graduate Studies before that deadline so that any problems can be resolved. Invoices that are not honoured due to late registration will become your responsibility.

University Registration Fees

In addition to the programme fees, you are required to pay mandatory **University Registration Fees** (Guild Fee and Amenities Fee) **every** semester.

*Note that University Registration Fees are **not** charged for registrations during the summer sessions.*

You must have a student ID card. This is billed for on first registration.

- Amenities Fees are currently \$940 per year or \$470 per semester
- Guild Fees are currently \$120 per year or \$60 per semester
- The ID Card fee is currently \$30 (billed once)

Re-registration for Research Paper/ Internship/Practicum and Fees

You may find that your Research Paper/Internship /Practicum is not completed in the first semester of registration. In such cases you must re-register every subsequent semester and each summer session until your Paper/ Report has been submitted and graded.

Examination re-sits or re-submission of coursework

If at any time during your programme you are unsuccessful in one component of a course and are given permission to re-sit the examination/ re-submit coursework, this is recorded on your transcript as a grade FE (Failed Examination) or FC (Failed Coursework). In these cases an **Examinations Only** or **Coursework Only** registration must be done administratively. You will need to email your faculty clerk in Graduate Studies within the first 3 weeks of the semester in which the course is next offered with details of the course code for which you are to be registered.

The cost of examination re-sits is calculated per credit as in the table below:

Re-taking a failed course

If at any time you fail a course outright, and are permitted to re-take the course, you will be required to self-register using CHOL during the appropriate semester.

This repeat registration attracts the full per-credit cost of the course again as calculated on a prorated basis.

Pre-programme workshops/seminars

Based on your academic background you may be required to undertake additional pre-programme workshops/ seminars/ courses. These additional requirements are billed for separately. Your Programme Coordinator / Academic Advisor will advise if this requirement applies to you.

Other Fees that apply

Production of Research Paper/Thesis

If you have to submit a Research Paper or Thesis, we estimate production costs at:

Research Paper	\$500 - \$600
Thesis	\$800 - \$1,000

Examination of Research Papers/Theses

All Theses and *some* Research Papers attract an administrative Examination fee. You should confirm with your faculty clerk in Graduate Studies whether your programme attracts this fee.
